# TRANSACTIONS TAB IN TRIDENT

A new tab is added to the policy details page called "Transactions". The transactions tab in trident provides the payment and refund data for issued transactions.

The account tab will still be visible to the underwriter users; and will still assist underwriters in understanding incoming payments for transactions that have not been issued.

The transactions tab appears ONLY on the policy details page.

ACCOUNT TAB	TRANSACTIONS TAB **New**
Visible to underwriters only. Agents cannot see this tab	Visible to agent users and underwriter users
Shows payments incoming into Trident for transactions that have not been issued.	Shows payment data for transactions issued. This is the data that underwriters currently view in "Current Account" in policy master.
Does not show refund data	Provides all users into data about issued refunds.
Does not show historic payment data.	Shows all current account data for all policy terms, displaying the newest on top. This allows you to see current and historic transaction details.



#### **KEY TO UNDERSTANDING TRANSACTION TAB**



- 1. Date payment entered the system.
- 2. Describes the type of transaction. Note that "check payment" means we received a check. Electronic payment means that we received a payment via pay.gov
- 3. Payee describes the entity of the party or person that made the payment.
- 4. Payee name is the name of the person or party that made the payment.
- 5. The amount is the amount of the payment, written transaction, or refund amount.
- 6. Receipt date is the "received date" for payments; and may be different than the date the payment entered the system.
- 7. Certified date is the certified cash receipt date that may apply to the payment
- 8. Check # / Remittance id provides the check number of an incoming payment, remittance id for a pay.gov payment, or check number of an outgoing refund check.



#### **REFUND DETAIL**

If the event is a refund or cancellation refund, the check number is a working link that you can click to view details about the outgoing check.

NOTE: if the check has not been issued by accounting; the check number will not be available.
